Florida SHOTS User Responsibility



Help Keep the System Protected and Secure

Florida SHOTS is located on a secure server with password-restricted access. We use the latest encryption, firewall safeguards, and the confidential information is only available to authorized professionals via a password-protected login.

Each organization enrolled with Florida SHOTS has at least one user designated as a Local Organization Administrator (LOA) to manage their account and ensure security. Some of the important responsibilities of LOAs are:

- Granting access to new users
- Unlocking accounts for users who are locked out
- Terminating system access for employees who leave your organization
- Reviewing and maintaining the Personnel List regularly

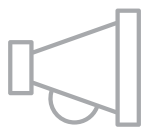

It's always nice to know what others who are enrolled in Florida SHOTS have to say about the program. In each issue, we share what some of our users think about the system. This interview features Susan Churchill, MSN, RN, Clinical Care Coordinator at Nicklaus Children's Pediatric Specialists Pediatric Care Center.

What do you think is the best feature of the Florida SHOTS for your office?

The training that is offered on the Florida SHOTS website is very informative and helpful, especially for new hires to the clinic. The ability to create Reminder/Recall reports within the system assists us in being able to reach out to patients and families who are due or overdue for vaccines.

What do you think is the best feature of Florida SHOTS for patients?

The accessibility of their child's record throughout the state provides for continuity of the record if the family relocates within the state of Florida.

How have you implemented Florida SHOTS into your workflow?

Each morning the nursing staff reviews our patient list and verifies their Florida SHOTS record against the patient's electronic chart. Any discrepancies are noted, and the records are updated prior to the end of the patient's visit. The ability to import vaccines from Florida SHOTS directly into our patient's electronic health record is a great feature. Also, the ability to create new records and add historical vaccines to the patient's record ensures an up-to-date document.

If another doctor's office were to call and ask you why they should enroll, what would you say?

Florida SHOTS is an excellent tool for vaccine management! The help desk is always there to assist and is an added bonus when you enroll.

DATA UPLOAD

Don't Forget to Check Your Codes!

Did you know that having incorrect or outdated CVX, MVX and VIS codes in your EHR's immunization table can result in vaccine messages getting rejected and not transferring to patient records? Make sure to regularly review and update to ensure you have the correct codes. See here for important links:

- 1. CVX code table:** Immunization codes sent by your EMR to FLSHOTS.
- 2. MVX code table:** Vaccine manufacturers table.
- 3. Vaccine Information Statements (VIS) dates:** These are the most up-to-date CDC patient vaccine information forms.

Upload Tip:

Patient ethnicity, as well as other data elements, are reporting requirements per the Department of Health, Emergency Rule 64DER20-43.



Did You Know?

Florida SHOTS is currently working on a new initiative with birthing hospitals across the state to match Vital Statistics records for newborn babies and their first dose of hepatitis B vaccine that is uploaded from the hospital. In the past there were challenges around this, and we've worked hard to update our system to match this data. 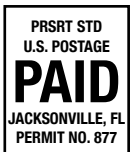
529 MILLION+ SHOT RECORDS

As of February 1, 2023, we've processed more than 529 million shot records via data upload from over 15,000 participating healthcare providers and multiple insurance organizations. There are also 2,993 real-time live web service healthcare provider connections through 145 EHRs.
